2 Policy

2.1 Information security principles

The following information security principles provide overarching governance for the security and management of information at LSE.

- Information should be classified according to an appropriate level of confidentiality, integrity and availability (see Section 2.3. Information Classification) and in accordance with relevant legislative, regulatory and contractual requirements and LSE policy (see Section 2.2. Legal and Regulatory Obligations).
- Staff with particular responsibilities for information (see Section 3. Responsibilities) are responsible for ensuring the classification of that information; for handling that information in accordance with its classification level; and for any policies, procedures or systems for meeting those responsibilities.
- All users covered by the scope of this policy (see Section 1.2. Scope) must handle information appropriately and in accordance with its classification level.
- Information should be both secure and available to those with a legitimate need for access in accordance with its classification level.
- Information will be protected against unauthorized access and processing in accordance with its classification level.
- Breaches of this policy must be reported (see Sections 2.4. Compliance and 2.5. Incident Handling).

2.2 Legal & Regulatory Obligations

The London School of Economics has a responsibility to abide by and adhere to all current UK and EU legislation as well as a variety of regulatory and contractual requirements.

A non-exhaustive summary of the legislation and regulatory and contractual obligations that contribute to the form and content of this policy is provided in Appendix A. Related policies will detail other applicable legislative requirements or provide further detail on the obligations arising from the legislation summarised below.

2.3 Information Classification

The following table provides a summary of the information classification levels that have been adopted by LSE and which underpin the 8 principles of information security defined in this policy. These classification levels explicitly incorporate the Data Protection Act's (DPA) definitions of Personal Data and Sensitive Personal Data, as laid out in LSE's Data Protection Policy, and are designed to cover both primary and secondary research data. Detailed information on defining information classification levels and providing appropriate levels of security and access is provided in the [Data Classification Standard](#).

A data protection policy or privacy policy is often known by law if your organisation collects personal information from your customers either online or in a physical store. The cybersecurity policy typically starts with a 'roles and responsibilities' section which outlines general security expectations for all employees in your organisation, including all outside consultants, administration, financial staff and of course all IT staff. You can download each document for a one time fee as low as \$9 or choose a monthly subscription. It lays out procedures to follow to avoid attacks on your information and systems which will minimise the probability of cyberattacks and thus major financial damage.A cybersecurity policy also includes a section on disciplinary action for your staff in the event of a breach which will help enforce your policy and keep everything above board.A lawyer is not necessarily necessary to write a cybersecurity policy as you can follow online samples of this policy or download templates. It's important to prioritise the areas of primary importance to your organisation which may be security for the most sensitive or regulated data. The document is vital for public companies and organisations, particularly those in regulated industries such as insurance, healthcare or finance.
